

#### **DOG ELIGIBLE TO ENTER**

This trial is open to all dogs SIX (6) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration, Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP), an AKC Canine Partners listing number or approved Foundation Stock Service (FSS) breeds are eligible to participate. Dogs with a Purebred Alternative Listing/Indefinite Listing Privileges (PAL/ILP) or an AKC Canine Partners listing number must be spayed or neutered in order to compete.

**Condition of the Dog.** Dogs with physical challenges(including amputees) are eligible to participate provided that, in the opinion of the judge, they display no signs of physical discomfort and can safely complete the . Dogs with bandages, sutures, or visible wounds are not eligible. Deaf dogs and blind dogs are allowed to enter. Dogs that are both deaf and blind are able to participate so long as the handler is in control of the dog at all times, the dog can complete the requirements of the class, and the dog does not appear to be under undue stress in the opinion of the judge.

**Crating:** Dogs will be crated out of view of the Fetch test area, or far enough away as to not cause a distraction to the dog being tested. Dogs must be crated. No loose dogs or x-pens allowed.

#### ADDITIONAL SITE INFORMATION

**Exhibitors are responsible** for cleaning up after their dog(s). Any exhibitor failing to do so may be excused without benefit of refund if the Event Committee deems the exhibitor to be in violation of this requirement. Cleaning supplies and disposal sites will be available at various locations around the show grounds.

**Restroom Facilities** are located throughout the grounds and in the main show hall.

While not actively competing, dogs MUST be on a fixed length 6' or shorter leash, INCLUDING entering and exiting testing areas in order to avoid dog to dog contact. Flexi leads are not permitted.

#### **RIBBONS, AWARDS, AND PRIZES**

Qualifying runs will be awarded a green flat ribbon.

A New Title rosette will be awarded to all dog and handler teams finishing a title.

Retriever title ribbons will be available to exhibitors who notify the trial secretary by August 12th.

Ribbons and prizes will not be mailed.

#### **NOTICE TO EXHIBITORS**

#### SAFETY, BEHAVIOR AND LIABILITY

The safety of the dog is our primary concern. By entering this trial, exhibitors acknowledge that they are familiar with the rules and regulations of this sport, and that their dogs are familiar with and able to perform all tests safely. It is expressly understood that exhibitors alone are responsible for the behavior of their dogs and/or children. Any exhibitor whose dogs and/or children create an unnecessary disturbance or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the trial committee, be asked to leave the show site. In such case, no refund of any fees paid will be made. The Giant Schnauzer Club of America and its agents, employees, etc., will assume no responsibilities for any loss, damage or injury sustained by exhibitors or handlers, or to any of their dogs or property and further assumes no responsibility for injury to children. The Giant Schnauzer Club of America reserves the right to decline entries for cause and may remove any dog on account of aggression. No one shall have any recourse or claim against the Giant Schnauzer Club of America or any official thereof.

Collars, Leashes and Harnesses: While not actively working, dogs MUST be on a fixed length 6' or shorter leash, INCLUDING entering and exiting areas in order to avoid dog to dog contact. Dogs must wear a collar. Dogs may wear slip collars, buckle collars, and Martingales in the AKC Fetch test. They may not wear prong collars, e-collars, head collars, muzzles, or body harnesses. Leashes should be 4 ft. to 6 ft. long and should be made of fabric, leather, or biothane.

All dogs must be on leash at all times, and retractable leashes may not be used when on trial grounds (except during judged tests). Dogs must enter and exit the test area with the leash attached to the collar or harness, including when waiting in the ready area before the test.

#### **REFUNDS**

**No entry fee will be refunded** if the trial cannot open or be completed by reason of riots, civil disturbances, fire, an act of God, public emergency, act of a public enemy, or any other cause beyond the control of the organizing committee. No entry fee will be refunded in the event a dog is absent, disqualified, excused, or barred from competition by the action of the Trial Committee. Dogs pulled after closing because of injury or other medical condition are not eligible for a refund.

**Bitches in season** will be refunded the full entry fee, however, bitches in season may compete in Fetch.

**Refunds will be mailed by the club** after the trial concludes. GSCA does not make refunds under \$10 - check your entry fees!

Electronic refunds will show on your credit card statement.

Online entries will be refunded less \$3/run online fee, this includes bitch in season, judge change, waitlist withdraw, and all other legally made withdrawals.


