Following the constitution, the board filled the vacancy of President with the Vice President, Bernie Tuerler. Carol Thordsen was nominated and elected to the Vice President position. The position of Eastern Director is now vacant; any Eastern Region member who has been a member for the past 24 months and is interested in this position should contact the board.

The latest issue of Giant Steps had the incorrect 2009 Award recipients. The list that was published was a very early draft compiled in May and inappropriately submitted to Steps for publication. That list had undergone numerous revisions even before being posted on the web site in May 2010, then revised in July 2010 and provided to the membership. The list that was published in July 2010 is the correct list. An explanation of the July revision is included in the July minutes included elsewhere in this newsletter. Traditionally the awards list is compiled then provided to the membership for review on line and by mail. It has not been published in Giant Steps until after the National

Specialty. The board would like to apologize for any

If you have an owner handled dog please notify Marina of your eligibility for that category.

Ed Watson has facilitated the collocation of Giant, Standard and Mini Schnauzer Meet the Breed booths at this year's AKC/Eukanuba show in Long Beach, CA, December 4 & 5. Ed has agreed to be the contact for this event, but additional volunteers and ideas are needed. If you have the time please contact Ed to assist.

New AKC Herding Regulations

Revisions to the AKC Herding regulations have been approved and are listed at: http://www.akc.org/pdfs/events/herding/Revisions Herding Rules 0710.pdf

Most changes are clarifications on the running of a herding trial. For the exhibitor the main changes are:

Instinct testing: dogs may enter an Instinct test at six months of age (it was 9 months) A course: Stock just following a handler with dog in heal position or off contact will not qualify A course: Exhibitor will remove the leash after closing the gate (use to be removed before entering) C course: Wide graze is now 8-15 minutes C course: Handler no longer needs to be on the opposite side of the dog on the re-pen A B and Tests: Although not specific to the handler, it may slow up runs, as now sheep need a 30 n

A,B and Tests: Although not specific to the handler, it may slow up runs, as now sheep need a 30 minute break between runs

The Importance of Your AKC Delegate

What are the unique powers of a Delegate?

- Approves Rules governing dog shows and field trials
- Approves amendments to the AKC Bylaws
- Nominates and elects Delegates to serve on the AKC Board of Directors & Delegate Standing Committees
- Approves new member clubs
- Votes to uphold or overrule an AKC Board decision to disapprove a Delegate candidate or to remove a seated Delegate
- Only a Delegate may serve on the AKC Board
- Votes to discipline , and even to expel, a Member Club

How do they exercise these powers?

- Attends and votes at quarterly Delegate Meetings
- Attends and/or Participates with Delegate Standing Committees
- Brings Member Club's proposals to the Delegates and/or Delegate Standing Committees
- A Member Club, through its Delegate, may propose amendments to the AKC Bylaws or AKC Rules directly to the AKC Board
- Informs all members of their Member Club of Delegate actions
- Acts as ombudsman for Member Club members dealing with AKC

What are the qualifications for a person to become a Delegate?

Required -- Article VI of the AKC Bylaws

- Represents a Member Club
- Both Member Club and individual are in good standing with AKC
- Is a resident US citizen or has permanent resident alien status
- Meets all of the occupational eligibility criteria
- May not have been found guilty of or admitted to the theft, embezzlement or misappropriation of funds or property from an AKC Club

Suggested -- for perspective and continuity

- Ten year involvement in AKC events and/or activities
- Willingness to serve for five years or more
- Willingness to invest time, effort and expenses
- · Willingness to speak up and become involved
- Willingness to engage others in crucial conversations

What should a Member Club expect from their Delegate?

- Long term (5 years or more) commitment to represent and serve the Member Club
- Commitment to attend and participate at Delegate Meetings
- A timely report on the actions taken at Delegate Meetings
- Presentation of actions/issues that will come before future Delegate Meetings
- When applicable, vote as directed by the Member Club

What should your Delegate expect from the Member Club?

- Long term appointment as Delegate
- A forum to report on what transpired at Delegate meetings
- Discussion and guidance on forthcoming actions/issues
- Assistance with Delegate expenses to expand who might become Delegates and to maximize their participation



Telephonic Board Meeting, July 6, 2010

Board Members Present: Bernie Tuerler, Sandi Anderson, Pam Foster, Carol Thordsen, Mike Rutkas, Joanne Thompson, Greg Reyna. Absent: Ed Fojtik.

<u>Call to Order</u>: 8:36 EDT by Vice-President Bernie Tuerler.

<u>Review & Approval of Board Minutes of Last Meeting</u>: Bernie moved to accept the minutes from the June 9, 2010 telephonic board meeting; Motion seconded by Mike; Motion passed unanimously 7-0.

Officer Reports

Report from the President: Absent

Report from the Vice President: See "Unfinished Business"

<u>Report from the Secretary</u>: Sandi reported she has sent hard copies dated June 10, 2010 and June 24, 2010 regarding club matters posted to the website to those members requesting same. She also referenced a letter from AKC recognizing the first ever Grand Championship in our breed, AKC Grand Champion CH Skansen's Bacchus II.

<u>Report from the Treasurer:</u> Financial Statements: Pam reported that she has completed 2010 financial statements through May 31 and forwarded them to the board; she is currently finishing June. She and Sandi agreed to establish a procedure for posting these reports to the website on a timely basis. <u>Invoices sent to Treasurer for reimbursement:</u> After a brief discussion Pam moved that any invoice over \$200 must be submitted by the treasurer to the board for approval; Mike seconded; Motion passed unanimously 7-0.

Regional Director Reports

<u>Report from the Eastern Director</u>: Carol reported she is investigating the 2010 Eastern Specialty to be held in Harrisburg on August 14th: due to potential problems encountered with the AKC application process which took place during the vacated Vice President position. She stated that the AKC Meet the Breeds event (October, 2010) is on target.

<u>Report from the Midwest Director</u>: Mike reported that the 2010 National Flyer is complete and posted to the website. Bernie questioned the Midwest hosting the 2011 National for which space has been reserved at Purina Farms from October 3rd through 8th, 2011. Mike and Bernie agreed to investigate the status of this event.

Report from the Southern Director: No report.

<u>Report from the Western Director</u>: Joanne reported that the West is looking into having a Giant Schnauzer Fun day in August of this year. She also stated that the West is considering volunteering to host the 2013 National.

Unfinished Business

Standing Rules: Bernie presented an overview of his research on club Standing Rules as follows: The Standing Rules that had been on the website as the November 2008 revision voted on by the Board are/were not valid. At the 2009 GSCA Annual Board Meeting there was a discussion brought to the table regarding the status of the club's standing rules, particularly those made after 1997; the subject was tabled for further investigation and discussion. After joining the board as Vice President in March 2010, the Club Standing Rules were brought to his attention and he contacted AKC, a parliamentarian, and reviewed Roberts Rules of Order, Newly Revised 10th ed (RONR (10th ed.) In compliance with Roberts Rules, AKC and the parliamentarian both stating that "Club Standing Rules are voted on by the club, and board standing rules are voted on by the board": Bernie moved that the official Club Standing rules of the GSCA are those dated 1997 as published in the 2007 GSCA Yearbook; Sandi seconded; Motion passed unanimously 7-0.

Conformation 2009 Awards: The board discussed the following: The Giant Schnauzer Club of America [GSCA] is governed by the GSCA Constitution and By-Laws, Club Standing Rules, and customs/past practices in that order of precedence. The GSCA Constitution and By-Laws do not address eligibility of awards. The change to Standing Rule #9 [dealing with Annual Awards] defining membership requirements was voted by the GSCA Board in January 2009. This modification was added to the proposed [but not approved] "Standing Rules Revision 2008". This revised Standing Rule is not valid as explained in the previous paragraph. According to customs/past practices concerning GSCA Annual Awards: a dog is eligible if the owner became a member at any time during the year. A random review of award recipients revealed that in each of the past four years, awards were presented to members who became members during the year, even as late as November. In review of that consideration, and the lack of validity of the "2008 Revision Standing Rules [Modified], and the review of financial documents provided by a member to support their claim of membership in 2009, the GSCA Board reviewed the eligible candidates for Annual Awards and made adjustments accordingly. In response to this discussion: Bernie moved that Conformation Giant Schnauzer of the Year-Bitch be awarded to CH Gallilee's Pure of Spirit, Owners: Mary Hayes, J&C Sanchez; Carol seconded; Motion passed unanimously 7-0. Bernie moved that Conformation Giant Schnauzer of the Year-Dog of be awarded to CH Skansen's Sir August Brigs, Owner: Mary Williams; Pam seconded; Motion passed unanimously 7-0.

Board Nominated Awards: The following were voted on by the board: Lady Fergie, Outstanding Giant of the Year, Prinz Wilhelm (Willie), Dedicated Service and AKC Sportsmanship. The President's award has been selected by Ed Fojtik. The board agreed that the winners of these awards will remain unpublished until following the 2010 National. (Note: Any board member who was in contention for a nominated award abstained from any discussion or vote on said award).

<u>Election of New Members</u>: Sandi reported that per an e-mail vote dated 05.25.10 regarding the pending applicants for membership as published in the April 2010 Giant Steps (Volume 46, Issue No. 1) who are: Seth Ganes, Trish Krause, Robin & Nathan Locklear, Jackie Mitchell, Manuel Parra, D. Jeffrey & Andy Blalack, Ivona & Roman Zuchowski have been granted full membership to the Giant Schnauzer Club of America by unanimous vote by the board.

<u>Additionally</u>: Sandi moved that the following applicants as published in the June 2nd 2010 Newsletter (Volume E-4) who are Susan Ballinger, Lisa Hawes, Gay Jo & Edward True Marne & Michael Tucker granted full membership to the Giant Schnauzer Club of America; Mike seconded; Motion passed unanimously 7-0.

New Business: None

Motion to adjourn made by Mike and seconded by Carol. Motion unanimously passed. Meeting adjourned at 11:45p.m EDT.
